To request a book, please send an e-mail outlining (1) the book of interest, (2) your anticipated deadline for completing the review, and (3) your mailing address (if you cannot pick the book up on Webster's home campus in Webster Groves). Also note your university and program of undergraduate study.

The review should contain a balance between description and critical evaluation. You will receive "Instructions for Authors" with advice and notes on appropriate formatting. The usual length for reviews is 1000-1500 words. Acceptance for publication is conditional on approval and editing by the editors. *If you would like to review a book not included in this list, please contact Dr. Kingston to discuss this option.*
